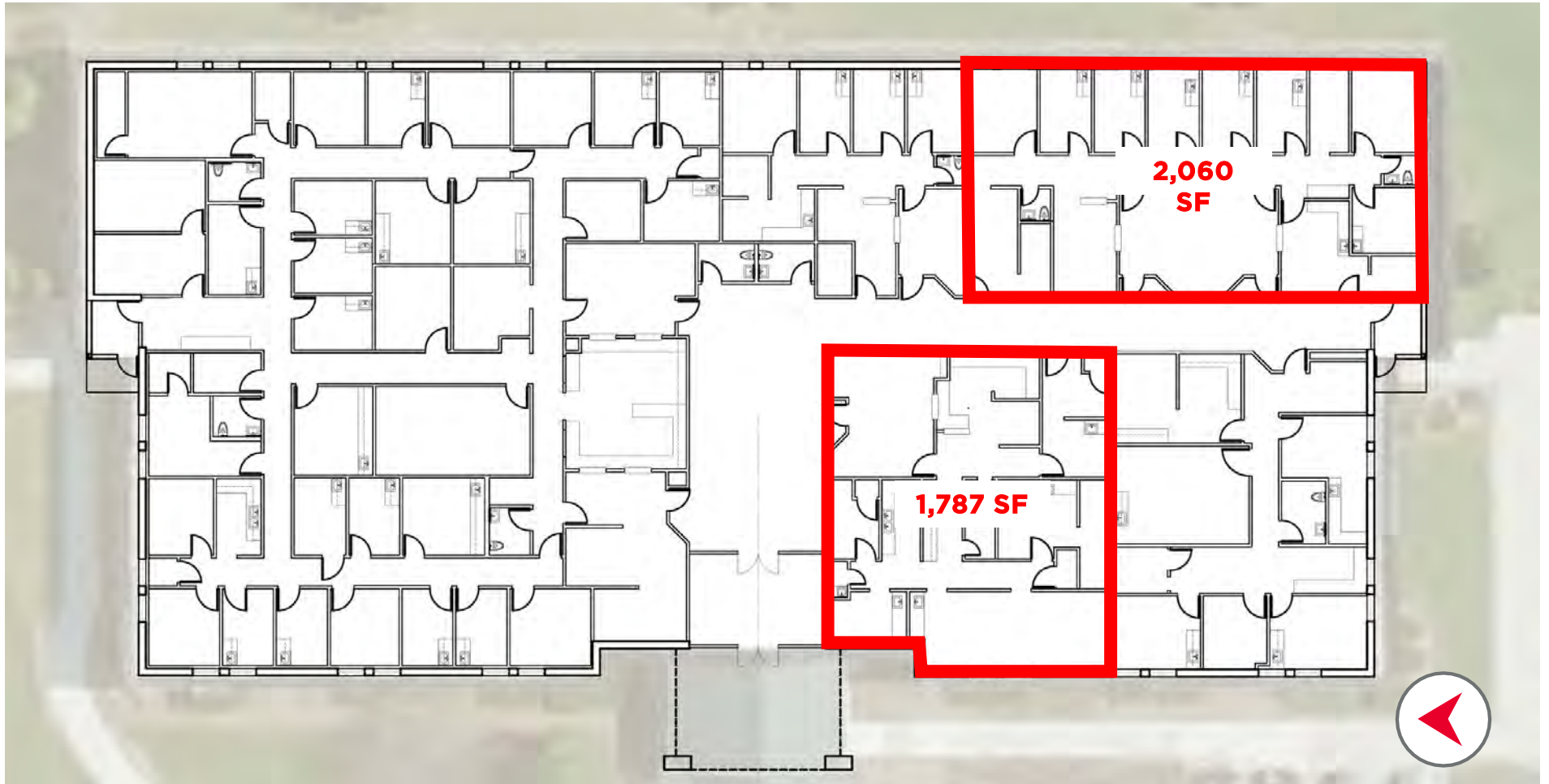

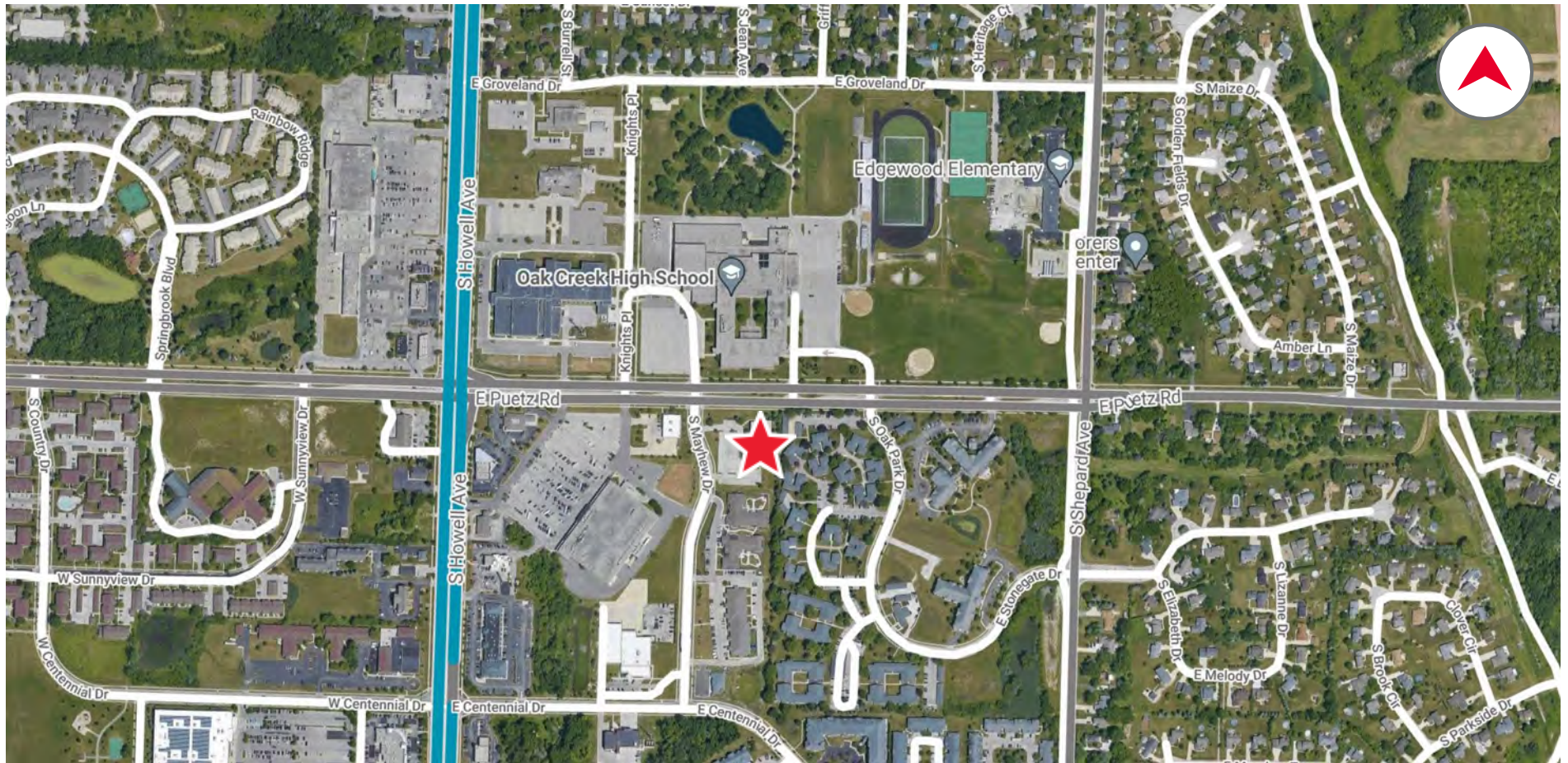

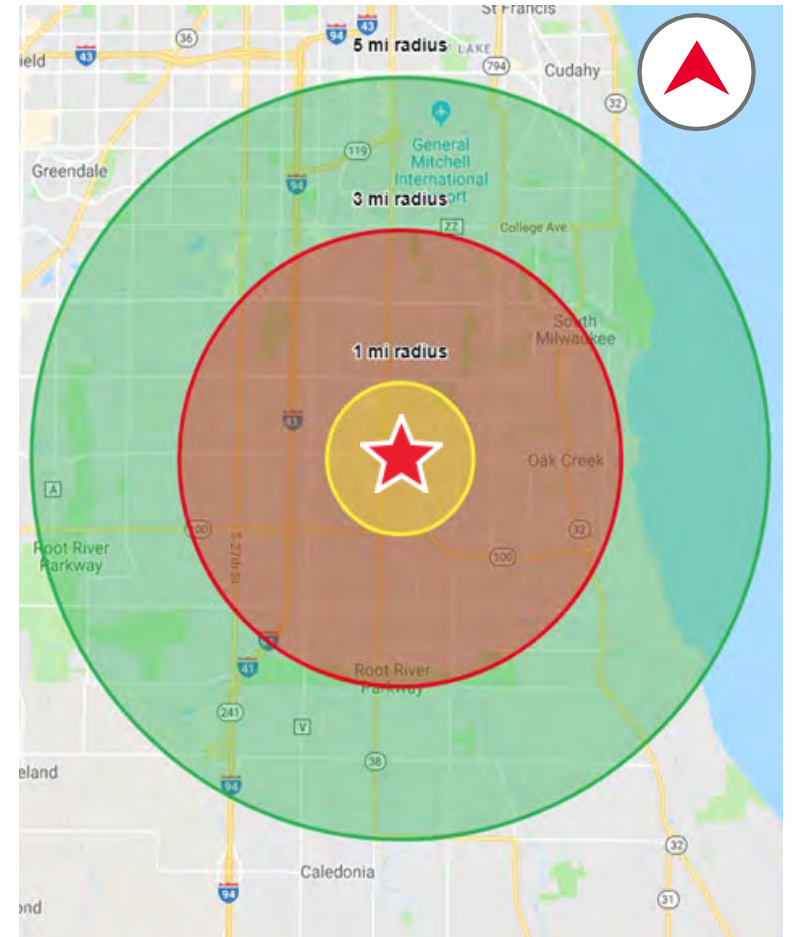

# STATE OF WISCONSIN

## DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS

### DEFINITION OF MATERIAL ADVERSE FACTS
